Interaction with the expert community within the framework of the RIA Institute in the Khabarovsk territory

The article is devoted to formation and use in practice of new institutions that allow predict the changes in the regional management system and to assess the corresponding potential effects. Organizational aspects ensuring effective interaction of government, business and civil society are considered. The possibilities of transforming the assessment of the regulatory impact at the regional and municipal levels into an effective instrument of economic policy are shown. The 5-year experience of using RIA (regulatory impact assessment) in the Khabarovsk territory is estimated.
