Physical culture and sport in the system of objective and subjective factors of the region

The article presents an analysis of statistical information and the results of sociological research of the attitude of the population to the conditions for physical training and sports, including in the context of age-based youth cohorts. On the example of the Khabarovsk region – the subject of the Far Eastern Federal District – the main reasons for the dissatisfaction of the population with conditions for physical training and sports, the level of provision of the population with various types of sports facilities, the level of the population systematically engaged in physical culture and sports are analyzed. Additional directions of the state support of attraction of youth to regular employment by physical training and sports as means of strengthening of health of the population of the region are offered.
