Migration potential of youth in the system of measures of the state regional policy

The article presents an analysis of the priorities of state policy aimed at regulating migration flows in the Khabarovsk territory, the main of which is the outflow of the indigenous population and the influx of low-skilled labor migrants. The positive experience of the implementation in the region of such instruments of retaining young people as “educational loans” and “savings capital”, “Far Eastern hectare” and “Zemsky doctor”, which can be successfully implemented in other regions of the Russian Federation of the Far-Eastern Federal District, is revealed. Taking into account the results of sociological surveys of recent years, fixing migration attitudes and orientations of the youth of the Khabarovsk territory, the main ways of improving the regional policy measures aimed at reducing the migration outflow of urban and rural youth and deformation of the social structure of the region have been proposed. The proposed measures are aimed primarily at improving the standard of living of the population and the transformation of socio-economic conditions of life in the region.
