Standardization of development of competition in the territorial subjects of the Russian Federation

The article is devoted to the topical issues of standardization of the competition and introduction of new version of the standard of development of the competition in the territorial subjects of the Russian Federation. The scientific perspective of the real research is caused by insufficiency of the dynamics of development of competition in the territorial subjects of the Russian Federation in a lack of the standardized reference points on achievement of the results of development of the competition. The importance of solution of a task of development of competition in the territorial subjects of the Russian Federation, branches (spheres) of economy of the Russian Federation on the basis of the unified approaches to the definition and achievement of the key indicators of development of competition in the commodity markets taking into account the regional and branch specifics is proved. It is determined that the standard of development of competition in the territorial subjects of the Russian Federation provides a regulation of actions of the public authorities regarding development of the mechanisms of realization of competition policy in the regional aspect, determines the independence of their actions and is a component of the standardized system of development of the competition. The results of carrying out comparative analysis of application of the separate components of the standard of development of the competition indicate the problems of social and economic development of the respective territories which are available and solved by the competition development that can form a basis for search of the best practice of instruments of development of the competition.
