The prospects for development of small and medium entrepreneurship in the Khabarovsk territory in the conditions of implementation of the national project

 $oldsymbol{T}$ he article analyzes the current state of small and medium-sized enterprises in the Khabarovsk territory, identifies the main trends in its development, substantiates the negative values of indicators. The necessity of developing of the small and medium-sized enterprises in the framework of economic reform in the country as a whole and with emphasis on regional specifics in the constituent entities of the Russian Federation is presented. Relevance at the national and regional levels of entrepreneurship development is confirmed by the approved national project "Small and medium-sized enterprises and support of individual entrepreneurial initiative". The national project offers the necessary measures to support entrepreneurs at all stages of the life cycle: from the idea, registration, receiving various types of support to expanding the business with export. The author analyzed and presented the uniqueness of the implementation of this national project in the Khabarovsk territory. The article outlines the main goals, measures and results of the national project in the context of its five subprojects: acceleration of small and medium-sized enterprises; expanding access of small and medium-sized enterprises to financial resources; promotion of entrepreneurship; creation of a support system for farmers and development of rural cooperation; improving the business environment. For each of the regional projects, an analysis was made of the goals, sources and amounts of financing, key activities, indicators and results of their implementation are also structured. Based on the analysis, the main vectors and prospects for the development of small and medium-sized enterprises in the Khabarovsk territory until 2024 are presented.
