Topical issues of implementation of the state policy of the Khabarovsk territory in the field of land relations

The article is devoted to the consideration of certain issues and especially to the implementation of the State policy of the Khabarovsk territory in the field of land relations. Of all the known instruments of implementation of this policy, the most attention is paid to the project "The Far-Eastern Hectare," implemented, in-cluding on the territory of the region. The purpose of empirical research is to sum-marize the actual data on the results of the project implementation in the Khaba-rovsk territory for 2016 - 2018, as well as to identify the most acute problems. It has been established that of the applications submitted for more than 80 percent, contracts have been prepared and concluded for the free use of land plots. The ex-amples of successful practices of using the provided plots are given. However, the scope of the project remains small, as evidenced by the fact that of the 29.7 million hectares of land free of charge, the total area of land provided is only 21.4 per cent of the land. It was concluded that the main problem holding back the interest of cit-izens in obtaining the Far-Eastern hectare is the lack of communal and road infra-structure near the most allocated territories.
